Registered Nurse First Assistant Theory, Practice, and Clinical Practicum NSG 488 1 (6.0 Credits)

Description

This course is designed to provide the learner with a comprehensive understanding of the perioperative process, building upon knowledge of anatomical structures and physiology, indications for surgical intervention, assisting considerations, intraoperative performance of surgical first-assisting techniques, and evaluation of postoperative patient outcomes. The didactic portion of this course will emphasize the expanded functions unique to the RN First Assistant including the legal, regulatory, and professional issues as well as the specific role of the RNFA in management of patients across the preoperative, intraoperative, and postoperative phases incorporating the three dimensions of Socialization Theory: professional socialization, organizational socialization, and role socialization. The clinical portion of this course will focus on the learner #39;s application of knowledge to safely perform the skills required during the perioperative process. Emphasis will be placed on the development of advanced surgical assisting skills, such as providing surgical site exposure, tissue handling, cutting tissue, suturing, providing hemostasis, using surgical instruments, and wound management. Students will collaborate and communicate with other healthcare providers to develop a plan of care to achieve optimal patient outcomes. In collaboration with a board-certified surgeon preceptor, as well as a RNFA or CRNFA mentor (optional), students will develop personalized learning objectives and identify learning resources to enhance the knowledge and skills necessary for competent RNFA practice and role development. Open to nonmatriculated students. Special application required.

- 6. If you are having difficulty completing the course by the course end date (incomplete contract end date) it is the students responsibility to contact the instructor to ask for more time.
- 7. Only one extension will be provided if the student has reasonable need (as determined by course faculty), unless there are extenuating circumstances
- 8. This course must be finished within a 2 year time period from the day the course starts. No extensions will be given after that time.

Course Learning Outcomes (CLO):

- - 1. Analyze factors influencing the role and scope of the role of the RNFA.
- 2. Integrate the independent and collaborative aspects of patient care, utilizing the nursing process as a framework.
- 3. Apply principles of asepsis, infection control, and epidemiology in best practices of nursing care of the perioperative patient.
- 4. Differentiate between abnormal anatomy and physiology as they pertain to the indications for surgical intervention, assisting considerations, and evaluation of postoperative patient outcomes.
- 5. Demonstrate communication skills necessary for collaboration and best practices for the RNFA.
- 6. Recognize the indication(s) for hemostasis, handling tissue, retraction/exposure, using surgical instruments and suturing.
- 7. Demonstrate competent intraoperative RNFA behaviors including (clinical): a. Preparation, positioning, draping b. Retraction, tissue handling, cutting tissue c. Suctioning techniques, providing surgical site exposure, hemostasis d. Suturing, use of surgical instruments e. Wound management.
- 8. Prepare appropriate preventive and corrective action for recognized surgical hazards. (clinical)
- 9. Provide postoperative care of patients in collaboration with other health care providers in the immediate postoperative period and beyond. (clinical)

Assignments & Assessments

Teaching Methods/Activities:

This course consists of both a didactic and a clinical component. The didactic portion of the course includes assigned readings in the course text(s) and assigned journal articles, online lectures, interactive online learning activities, a guiz and a final exam (~16 hours) for a total of 48 hours of content. Teaching methods include lectures using a variety of media, PowerPoint slides, videos, critical thinking exercises, demonstrations, discussions, return demonstrations (skill practice), audio-visual teaching, independent study, online interactive learning activities, and competency evaluation of technical and manual dexterity skills. During the didactic, students are expected to complete required reading of selected textbooks/articles and scholarly/professional participation in discussions.

This course also consists of a clinical practicum with a requirement of 200 clinical specific hours. Of the total 200 hours, 150 hours must be "hands-on" first assisting directly in the OR with a board-certified surgeon preceptor. The remaining 50 hours may be any phase of perioperative nursing in the expanding RNFA role (pre/intra/post op). Clinical internship may

begin after successful completion of all didactic requirements AND once the University of Rochester School of Nursing receives all mandatory paperwork from the student, along with a memorandum of agreement between the University of Rochester and the clinical site, and the clinical site insurance forms.

In order to pass the didactic portion of the course and start the clinical portion of the course, you must receive ≥ 80% on each of the above course requirements.

Remediation

APRN's without experience in perioperative patient care must undergo an assessment by the program instructor. The assessment will include competency in preoperative and postoperative care, aseptic technique, scrubbing, gowning, gloving, creating and maintaining a sterile field, and positioning the patient. If it is determined that the APRN's knowledge or skills are still deficient despite additional opportunities for practice, course faculty will discuss a remediation plan during the on-site intensive on a case-by-case basis.

This course is entirely online with the exception of one in-person clinical simulation day, so the only way course faculty have to contact you is through the email you used to sign up for this course. You should be checking that email at least 3-4 times per week in case course faculty are trying to contact you. This is extremely important. Please feel free to contact course faculty with any questions.
